Whatever their careers, candidates must have made an important and valued contribution to the competitive intelligence profession. That contribution must be documented and supported by individuals who can personally attest to the importance

and value of the candidate's contribution. Activities that would qualify a candidate for Catalyst nomination would include, but not be limited to the following:

- Exceptional local-level promotion of SCIP
- Significant contributions to the operations of SCIP (for example: chapter operations)
- Practiced high ethical standards

**Presentations/Publications:** Major presentations, publications, etc. on the topic of Competitive Intelligence or promotion of SCIP
